- 4) **Applications will not be processed if the above items 1 through 3 are not submitted.** After your application has been reviewed and approved, you will be sent an "Agreement to Sublease CUP Water for Five Years". You must sign the agreement and return it with your payment to SWUA, 745 N 500 E, Payson, Utah 84651. Your application and Sublease Agreement will then be reviewed by Central Utah Water Conservancy District (CUWCD) for final approval. SWUA will notify you and your canal company when your CUP Water is released.

My canal company may also charge a delivery fee. The CUP Water will be used for irrigation on the number of acres of eligible lands approved by CUWCD, and the SVP Water will be used first. I will not be able to carry over or hold water from year to year. I can terminate the lease with a 60 day written notice, however past due balances must be paid.**
